USING YOUR G2-PAK®

I. OVERVIEW

Our recycling service is an easy to implement and inexpensive solution for businesses to recycle aerosol cans in a responsible way. You'll have up to **one year** from purchase date to mail back your g2-PAK® container.

Pack up your used, expired, or returned aerosol cans to send to our US facility for responsible recycling. It is crucial that you follow all instructions and read through the Terms and Conditions to ensure all regulations are followed. It is your responsibility to abide by local and state laws.

After your service has been completed, you will be emailed a digital **Certificate of Recycling** as proof that your materials have been recycled and successfully avoided the landfill.

With your help, we are Changing The Way The World Recycles®.

II. ACCEPTABLE ITEMS

(Cans can be empty, partially full, or full)

- Spray paint
- Air Freshener
- Sanitizer
- Hairspray
- Food Products (cooking spray, whipped cream, etc)
- Pesticide / Bug Spray
- Degreaser
- Foam Deodorizer
- Compressed Air dusters
- Disinfectant
- Spray Adhesive

III. PROHIBITED ITEMS

- Punctured cans
- Actively leaking cans
- Unlabeled products
- Poisonous liquid, paste, or powder
- Radioactive products
- Prescription Medicines
- Medical Devices
- Sharps (needles, etc)
- Controlled Substances

IV. ASSEMBLING AND USING THE CONTAINER

Fully illustrated instructions for box setup and use are located on the back panel of your container.

STEP 1: Push together box sides to automatically lock bottom flaps and form bottom of box. No tape is needed.

STEP 2: Open and place the plastic liner in the box, slightly hanging over box sides.

STEP 3: Fold top flap in half (inwards) and push until it hits back panel to form the box billboard. Side slots will lock it into place.

STEP 4: Open and place the partition insert into the box. Flip up front flap to form box lid.

STEP 5: To recycle, flip open lid and place only one aerosol item into each cell. Keep lid closed unless placing an item inside.

STEP 6: When full, fold the plastic liner over cells and tape or use provided zip tie to close. Fold top side flaps and tuck into sides to close top lid.

STEP 7: Secure box by first unfolding top flap and sliding front tab into slot on lid then locking in smaller, front tab.

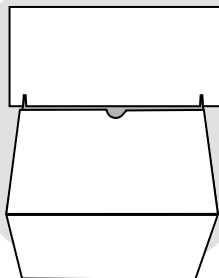

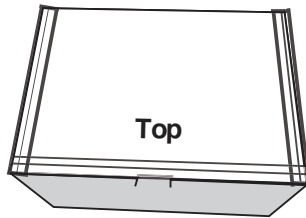

V. SHIPPING THE CONTAINER BACK

After your container is full and closed, you will present it to UPS for return shipment using the included prepaid shipping label. Please ensure that your container will be accepted by g2 by adhering to the following:

- ONLY use the provided g2-PAK[®] container
- Do NOT exceed the maximum return weight
- ONLY send in acceptable material for recycling
- Send in container BEFORE one year service expiration date
(*We do allow a 10-day grace period past service expiration*)
- Seal top edges of container with packing tape in a U-pattern:

G2 REVOLUTION ONLINE SERVICES TERMS AND CONDITIONS

These terms and conditions ("Terms") apply to the following services ("Services") provided by g2 revolution: Plastic Bags & Film Recycling, Mixed Recycling, Aerosol Can Recycling, Battery Recycling, Fluorescent Lamp Recycling, LED Lamp Recycling and Electronics Recycling.

The Services are provided by g2 revolution, LLC ("g2") to the Customer ("You"). These Terms are effective as of the date You agree to these Terms ("Effective Date") and govern your use of the Services, including your use of the g2-PAK® Container ("Container") in connection with the Services and the relationship between g2 and You.

THIS IS A LEGALLY BINDING AGREEMENT

PLEASE REVIEW THE TERMS CAREFULLY. PURCHASE OF g2 SERVICES CONSTITUTES ACCEPTANCE OF THESE TERMS. THESE TERMS ARE SUBJECT TO CHANGE WITHOUT NOTICE, FROM TIME TO TIME, AT g2'S SOLE DISCRETION. g2 WILL NOTIFY YOU OF AMENDMENTS TO THESE TERMS AND CONDITIONS BY POSTING THEM TO THE FOLLOWING OR OTHER DESIGNATED WEBSITE: shop.g2rev.com

SERVICE GUARANTEE

If materials within a Container received by g2 conform with instructions, and the Container is packaged and shipped in accordance with the instructions, g2 guarantees that materials will be sorted, processed, and recycled in a sustainable manner. Recycling will be in compliance with state and federal environmental law.

ORDER CANCELLATION

If an order has been placed accidentally, please contact our Customer Service Team at shop@g2rev.com or (888) 513-4222 as soon as possible to see if your order has shipped. Only if the Container has not yet shipped will there be an opportunity to cancel an order with a full refund.

REFUNDS

Refunds for Services are only accepted within fifteen (15) days from date of purchase. To be eligible for a return, the Container for the purchased Service must be unused and in the original packaging that you received it.

To start the refund process, email shop@g2rev.com with your order number and request or call us at (888) 513-4222 and a team member will assist you. If the Container is received by us and is deemed unused, undamaged, and within its original packaging, the refund amount for the Service will credit your original payment method within 3-5 days.

Each Service purchased is only eligible for a refund of 70% of the total purchase price once it has shipped and/or received to cover restocking and return shipping. g2 will email a shipping return label to You for shipping back a Container within its shipping box for a Service refund. **DO NOT SHIP BACK THE CONTAINER USING THE PREPAID SHIPPING LABEL.** This will VOID any refund.

ORDER REJECTION

Any order that appears to be placed for resale purposes through a dealer or distributor is prohibited. g2 reserves the right to cancel any order that is deemed for this use.

SERVICE RESTRICTIONS

SERVICES ARE APPROVED FOR USE IN USA ONLY. NOT FOR EXPORT.

Services are NOT available in Alaska, Hawaii, Puerto Rico, Maine and Vermont. Aerosol Recycling services are not available in Alaska, Hawaii, Puerto Rico, Maine, Vermont and Washington state.

SERVICE EXPIRATION AND CERTIFICATE OF RECYCLING

The g2-PAK® Container will arrive predated with the ship date and You will have **ONE YEAR FROM PURCHASE DATE** to mail back using the prepaid return shipping label. The filled date box has been provided for your convenience to track compliance of Universal Waste, as applicable. g2 will allow a 10-day grace period for receiving each Container from the expiration date.

If You return the container to g2 within **ONE YEAR OF THE START DATE** that is on the container, g2 will process the Container for recycling and provide You with a Certificate of Recycling. The Certificate of Recycling is our warranty that the materials in the Container have been properly recycled in compliance with regulations and to the extent practicable.

If the Container is returned to g2 by a date more than **ONE YEAR and 10 days** after the **START DATE** on the container, g2 will make its best effort to recycle the material but no Certificate of Recycling will be issued.

Please note that some states and the federal government have “Universal Waste” regulations for businesses that can apply to certain types of materials You put into Containers for recycling (such as batteries and fluorescent lamps). g2 is not responsible for any regulatory compliance obligations You may have due to Universal Waste regulations, including but not limited to any training, record-keeping or reporting requirements.

NON-CONFORMING MATERIALS

Please be sure to ship only the specific materials listed on the particular Service product web page, on the Containers themselves, as well as listed on the included instruction packet.

If You send g2 materials that do not conform to these instructions (“Non-Conforming Materials”), for any reason, You agree to any additional shipping and handling fees, at g2’s option. If You do not return the materials in the original Container for the purchased Service, g2 reserves the right to reject the shipment outright and charge additional shipping and handling fees for the Non-Conforming Materials. If you send in conforming materials, but the Container is over the stated weight, g2 reserves the right to charge fees for the additional material.

ELECTRONICS AND PRIVATE INFORMATION

You are responsible to remove any and all confidential and/or personal information and data from all items mailed to g2 for recycling. The recycling process for all electronics items renders them nonfunctional. g2 shall be held harmless and bear no direct or indirect liability whatsoever for any information that may be stored on electronic devices shipped to g2 for recycling.

INDEMNIFICATION

Customer agrees to indemnify, defend and hold g2 harmless from and against any and all liability which g2 may be responsible for or pay out as a result of bodily injuries (including death), property damage, or any violation or alleged violation of law to the extent caused by breach of these Terms or by any negligent act, negligent omission or willful misconduct by You, or employees, agents or contractors You use in connection with these Services; in the performance of these Terms, including any matter relating to a carrier shipping a Container; or use, operation or possession of any Container furnished by g2; or any occurrences related to Non-Conforming Materials. g2 shall not be liable for special, consequential incidental or punitive damages arising out of the performance of the Terms. These Terms regarding indemnification will survive any termination of the parties' relationship.

In no event shall g2 be responsible for any incidental damages in connection with these Terms not being followed or your use of our Containers.

ARBITRATION

You and g2 agree that any dispute or claim arising from or relating to the Terms shall be finally settled by final and binding arbitration only, pursuant to the Ohio Arbitration Act ("OAA"). Any arbitration under the Terms will take place on an individual basis — class arbitrations and class actions are not permitted. You understand that by agreeing to the Terms, You and g2 are each waiving the right to trial in court, by jury or to participate in a class action or class arbitration.

CHANGES TO THE TERMS

We may update these Terms from time to time. Changes will be effective upon the posting of the changes unless otherwise specified. You are responsible for reviewing and becoming familiar with any changes. Your use of the Services following any changes constitutes your acceptance of the updated Terms.

POLICY ENFORCEMENT

The Terms, including all of the policies that make up the Terms, supersede any other agreement between You and g2. If any part of the Terms is found to be unenforceable, that part will be limited to the minimum extent necessary so that the Terms will otherwise remain in full force and effect. Our failure to enforce any part of the Terms is not a waiver of our right to later enforce that or any other part of the Terms. We may assign any of our rights and obligations under the Terms.
